- 1. User will not use the ISU Library Equipment in an inappropriate manner. This includes but is not limited any use that conflicts with:**
 - a. Copyrighted materials
 - b. Patents
 - c. Trademarks
 - d. Registered Designs
 - e. Any other proprietary object
 - f. Prohibited by local, state or federal law.
 - g. Unsafe, harmful, dangerous, or that pose an immediate threat to the well being of others.
 - h. Obscene or otherwise inappropriate for the college environment.
 - i. In violation of another's intellectual property rights.
 - j. In violation of ISU & Library rules, policies, and procedures.
- 2. User will use the ISU Library Equipment in a safe and appropriate manner:**
 - a. Follow all ISU & Library rules, policies, and procedures.
 - b. Leave the Equipment in the same condition as originally found
 - c. Not attempt to repair the Equipment on my own.
 - d. Not cause any physical damage to the Equipment.
 - e. Pay for any damage incurred outside normal wear and tear.
 - f. Inform Library staff if the Equipment becomes unsafe or is in disrepair.
 - g. Pay for the materials used or provide my own materials if needed.

User accepts the Equipment "AS-IS" and it is User's sole responsibility to determine if Equipment has the capacity and capability to accommodate the use contemplated under this Agreement. Any person using equipment does so at their own risk and impliedly accepts Equipment in the existing conditions. User shall hold harmless, defend, and indemnify University, its officers, officials, employees, and agents, and the State of Idaho against and for all liability, cost, expenses, claims and damages for which University might otherwise become liable by reason of any accidents, or injuries to or death of any persons, or damage to property, or both, in any manner arising or resulting from, caused by, connected with or related to the use of the Equipment, regardless of how, where, or when such injury, death or damage occurs or if caused due to conditions or operation on or defects in the Equipment. User understands that they are financially responsible for all damages, loss, or theft that occurs to the Equipment while Equipment is in their possession. The User understands that they must return all checked out Equipment/technology to a staff member at the library's main desk.
