University Library Committee

Minutes: October 16, 2009

The meeting was called to order at 3:50pm in Library B-6 by Chair Stephanie Christelow. The meeting was to start at 3:30, there was some confusion due to the change of time and location. Those in attendance were Kay Flowers, Cathy Gray, Andrew Holland, Vitit Kantabutra, Pamela Knight, Sandra Knighton, Linda Leeuwrik, Pamela Park, Shalene Summers, Jean Thomas and Rick Williams. Guests included Sandra Shropshire (AUL for Collection Development & Technical Services), Leonard Hitchcock (Professor Emeritus), Cheryl Sebold, Mary Lou Beran and Ruiling Guo, bibliographers. Excused: Glenda Carr, Nancy Devine, Lance Erickson, and Kathleen McCullogh.

Dr. Jean Thomas, Education Leadership & Technology was introduced as the new representative from the College of Education.

The minutes from Sept 18 were reviewed. Williams moved to approve the minutes, Leeuwrik seconded the motion, and all voted to approve them.

Old Business:

Christelow presented the issue of voting on the by-laws and it was noted that the by-laws sent out to members were unrevised and did not reflect the changes. A correction was made to Article 5 to read a "majority of those present to pass a motion". A vote on the changes proposed today and at the September meeting will be voted on in November. A request was made to have the changes highlighted in the version sent out before the November meeting.

New Business:

Sandra Shropshire presented the results of using an allocation formula for the departments in the College of Arts and Sciences. She had hoped to have this completed for all colleges, but there were difficulties. The formula was based on each department's research needs, which is reflected in the number of faculty and graduate students, journal costs, journal expenditures, and the number of grants awarded in 2008. Shropshire emphasized the formula was only applied to journals, and that there are some departments that focus more on books, rather than journals.

To explain this allocation formula, Shropshire distributed two handouts, "Library Allocation Formula: Journals Allocation for Graduate Component" and a spreadsheet with the information listed and calculations made for each department. Shropshire noted that when the formula was strictly applied, more than half the departments' allocations were negative, which meant they owe the library funds. However, a decision was made that each department needs a base level of allocated funds, and some funds would be taken from those that have excessive amounts. However, no department would be cut more than 15% of their 2008-09 allocation, and some departments that previously received minimal allocations may grow up to 130% of their 2008-09 amounts.

There was quite a bit of discussion on the allocation information. Many questioned the impact of the grant funding on the formula, and Shropshire said when they calculated the allocations without the grant information, there was very little change. Also, publications (either number of pages or number of publications) should be factored in. She was asked to present this information again in November and redo the allocation formula without the grants. In addition, several asked if Teri Peterson (ISU statistician that helped with this project) could attend and explain formula to the ULC at November meeting.

With a great deal of discussion on this issue, no motions were made, although members were encouraged to discuss the journal allocation documents with their department faculty.

The meeting was adjourned at 5:00pm when Media Center staff notified us they needed to lock the doors.

Determination of journals need utilizes four factors:

Demand headcount: Faculty=1; Masters Level=.25; Doctoral Level=.5
 Sources: Faculty—FTE in ISU annual budget, clinical faculty, lecturers, instructors excluded; Students—Institutional Research report "Graduate Enrollment by Level and Status"

2) Total cost of journals: Average price in discipline X Number of journals* in discipline. *Academic, refereed, active, English.

Sources: Journals cost—annual periodicals price survey in *Library Journal* April issue; Number of journals—Ulrichs Periodicals Directory.

3) Departmental journals allocation as proportion of all departmental library materials allocation

Source: Library accounting system (Voyager)

4) Number of grants awarded per department*.

Sources: (internal) Office of Research report "Internal Grant Awards"; (external) Office of Research custom report.

*Faculty grants only—student grants not attributed by department.

Additional notes:

- No central source to gather faculty publication data. Would need rubric to measure if developed.
- Ceiling of 130% and Floor of 85% invoked in order to avoid negative allocations
- Allocations are by college
